“Life Happens,” Is Theme of 2010 Commencement Ceremony

Wearing environmentally friendly caps and gowns, 450 members of the Class of 2010 received bachelor's degrees during Charter Oak State College's commencement ceremony held June 5. The youngest of the graduates was 17; the oldest, 80.

An honorary degree, Doctor of Humane Letters, was presented to Astrid T. Hanzalek, former Chair of the Board for State Academic Awards (BSAA), a position to which she was appointed in 2007 by Connecticut Governor M. Jodi Rell. As a member of Connecticut's House of Representatives (1971-1981), Hanzalek took a leadership role in the

creation of the BSAA, the governing body for Charter Oak State College and the Connecticut Distance Learning Consortium (CTDLC). She has been recognized on numerous occasions for her dedication, leadership and public service in public policy and environmental organizations.

Charter Oak president, Ed Klonoski, addressed the graduates. The student speaker was Oxford, CT resident, Lisa Wildman, who serves as student representative to the BSAA and is a Student Association Council member. The ceremony was webcast across the country to graduates unable to attend in person.

THE PRESIDENT'S TAKE



As part of its ongoing strategic planning process, the College has created something we call *The Visioning Team* whose mission is to keep all entities within the institution focused on achieving the strategic goals we've established for ourselves. Creating a vision for an organization, then linking subsequent decisions

and strategies to its realization, is much more difficult than corporate management textbooks make it sound. Often, vision falls victim to daily pressures, sudden crises, and a variety of other pressing concerns. But in reality, nothing is more important to the health of an organization than a shared vision and the feeling, by each participant, that he or she is making a key contribution to achieving it.

So we created a visioning team comprised of a nucleus of staffers who were already spending time on activities related to the strategic goals of the College. These were the folks who were measuring progress and then imagining what needs to be done next. So the Charter Oak Visioning Team is comprised of four executives and three key directors. Those three directors selected a faculty representative and an additional staffer to bring our total number to nine. We meet every two weeks.

The team's initial challenge was creation of a vision statement. I was more than a little nervous about this. I worried that we wouldn't agree on content, or that we might not be able to find the proper language to clearly express the vision. Well, my worries were for naught. After only two meetings the group created this insightful statement:

“Charter Oak State College: A dynamic community of online learners, advancing the nation’s workforce one graduate at a time.”

This statement is both internally and externally directed. It is aspirational, which means it is meant to be a reach; and it is specific, which means we are trying to grow along a specified path. That is why the team used the word “workforce.” If we were a liberal arts college, we would have used a word like “citizenry.” But as an adult-serving, degree completion institution, the best descriptor we

could find for our audience and for our niche in the world of higher education is WORKFORCE.

We have shared this phrase with students, alums, staff and our faculty. We shared it with the Board at the May meeting, and we will begin

using it in our communication. As you receive more of these communications, you will see that we are trying to organize our efforts to make this vision a reality. For example, we have just chosen a company to help us research academic programs so that we can develop new programming that really does “advance the nation’s workforce.” And the new document scanning system we are purchasing will move more of our work online, making our goal becoming a “dynamic community of online learners” more accurate within our administrative walls.

You will hear more about both the Visioning Team and our progress in achieving our vision in future posts.

In his remarks, Klonoski noted the untraditional nature of Charter Oak students and the sometimes difficult and circuitous route they take to earn their degrees. He characterized the graduates as ‘second- chance learners’, often balancing work and family while completing their degrees. He told the graduates, “As you know better than I do, today did not happen by accident. It most likely began a number of years ago...and I suspect it didn’t go smoothly. Things happened that derailed your first efforts at college. Life happened.”

Klonoski continued, “...life happened, and your degree hopes were put aside. But that dream of a degree didn’t die when you turned 25. It is true that many of you had your education derailed by life events, but it is equally true that each of you is here because some other life event drove you to start back up and persevere until you finished.”

The College’s president concluded by encouraging the graduates to “Never doubt that you can accomplish great things. You have. You graduates are

proof to yourselves and to the rest of us that we can all achieve great things, not in spite of what life throws at us, but because life happens.”

Shirley Adams, Charter Oak’s Provost, in addressing the graduates and their guests, noted that 61% of the Class of 2010 were women, that 69% were Connecticut residents; that 24% were minority; and that class members hailed from 35 states and 12 countries. 🌱

Charter Oak Presents, Learns at Jenzabar Annual Gathering

In June, eleven members of the Charter Oak staff traveled to the 2010 Jenzabar annual meeting, held in Orlando, Florida, to both learn from and inform their contemporaries representing institutions of higher education from across the nation.

Jenzabar, Charter Oak's 'student database,' is software designed to support institutional success by optimizing administrative operations

You simply can't call him anything other than 'worldly'!

Meet the accomplished David Matthews, a member of Charter Oak's Class of 1992. He grew up in Morocco, France and Turkey. Always on the move and never able to pursue an undergraduate college degree as a traditional student, he earned his BS in Political Science from Charter Oak in 1992. "Without Charter Oak," he says,

"it would not have been possible for me to accomplish what I have to date. I am so grateful."

And accomplish he has! Begin with February of this year when he arrived in Kabul, Afghanistan to begin his deployment to the International Security Assistance Force Headquarters – part of the U.S. Department of Defense Civilian Expeditionary Workforce – where he serves as the primary expert of Economics and Development and is involved with counterinsurgency strategies. Prior to that: a two year stint with the Department of State as Senior Economic Advisor/Team Lead for the Provincial Reconstruction Team in Diyala Province, Iraq.

Following his Charter Oak educational experience, David earned an MCF in Public and International Affairs at Princeton. Most of his career has been spent in the private sector managing business operations that include construction, redevelopment, land use and manufacturing. He has additionally served as management consultant,

negotiator and investment advisor to numerous business entities. He 'took a break' from the business world in the mid-90s to serve as Country Director for the Peace Corps in the Kyrgyzstan capital of Bishkek.

And with all this career activity where, you may ask, has he found time to become an instrument-rated pilot for aircraft and balloon; to sail with the Soviet team in the Whitbred Round of the World Race (now known as the Volvo Ocean Race); to climb Kilimanjaro, Huascaran and Rainer; and to become an accomplished woodworker, rower and skier?

We'd like to think it's all a result of his Charter Oak blood line!

New Funding Boosts WIT Program

Charter Oak State College's Women in Transition program (WIT), a unique distance learning and technology initiative designed to assist underserved and underemployed single Connecticut mothers, has received new funding.

Now in its eleventh year, WIT has been sustained by generous donations from the corporate community and foundations and from federal, state and institutional financial assistance as well as internal College resources. The program has been newly refreshed through commitments for financial support from several sources including a \$40,000 grant from Hartford Foundation for Public Giving. Other entities contributing financial support were Leipold Foundation, Inc.; Daphne Seybolt Culpepper Memorial Foundation, Inc.; the Smith Whiley Foundation; NewAlliance Foundation; Main Street Community Foundation (Bristol, CT Women's and Girls' Fund); and the Charter Oak State College Foundation. This new funding will allow Charter Oak to open doors to college degrees for qualified women in many Connecticut communities.

Since WIT's inception in 1999, more than 150 students have enrolled in the program. To date, 45 have earned bachelor's degrees, 12 received associate degrees and an additional 16 were recipients of both associate and bachelor's degrees. Forty-two WIT students are currently working toward degree completion.

Students accepted into WIT are loaned laptop computers and provided Internet access allowing them to participate in the online program. They additionally receive financial support for college tuition, fees and the purchase of textbooks. To qualify for the WIT program, participants must be single mothers working in low-paying jobs and must have earned at least 21 college credits prior to matriculating at Charter Oak. They must also meet federal student financial aid requirements and be

prepared to take a minimum of two courses each semester.
